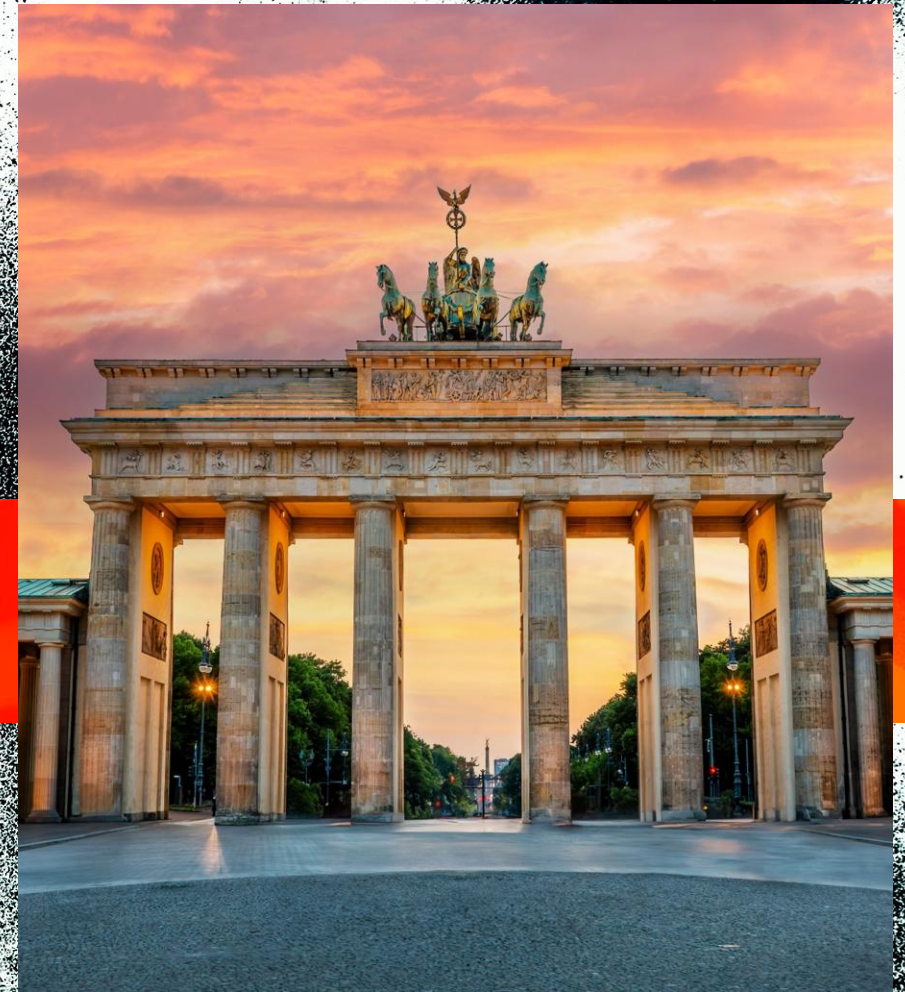

For exhibitors and visitors attending this landmark event in Berlin, Germany, a visa may be required depending on your nationality.

This guide provides a comprehensive overview of the visa application process to help you prepare and secure the appropriate documentation for your journey.

Key Points:

- Germany, as a Schengen member state, requires visitors to obtain a Schengen visa for stays up to 90 days unless exempt.
- Start the visa application process early to ensure timely processing and avoid last-minute delays
- GITEX EUROPE cannot guarantee that your visa application will be approved, as this is solely at the discretion of the German consulate or embassy.

DO I NEED A Schengen Visa?

*Applicable Rules

Please review the following points according to their numbers, as they correspond to your country, indicating whether a visa is required or if you are exempt.

- 1) Persons who do not require a visa to enter Germany may not remain on German territory for **more than 90 days in any 180-days period**. Nor may they take up gainful employment whilst here. German entered into bilateral visa waiver agreements with certain countries which, under certain circumstances, allow for a stay in Germany exceeding the period of 90 days in any 180-days period. More detailed information in this regard can be obtained at the [websites of the German embassies and consulates](#) in the respective countries.
- 2) Holders of ordinary passports issued **on or after 25 May 2015**.
- 3) Residence permits (also for stays of more than 3 months) may be applied for after entering Germany without a visa.
- 4) Footnote 3 also applies provided gainful employment is not taken up.
- 5) The visa waiver applies **only** to holders of biometric passports.
- 6) The visa waiver applies to holders of **SAR passports** (Hong Kong and Macao Special Administrative Region passports). These may not remain on German territory for **more than 90 days in any six-month period**. Nor may they take up gainful employment whilst here.
- 7) The visa waiver also applies to British Nationals (Overseas).
- 8) The visa waiver applies only to holders of biometric passports (excluding holders of Serbian passports issued by the Serbian Coordination Directorate (in Serbian: Koordinaciona uprava)
- 9) The exemption from the visa requirement applies only to holders of passports issued by **Taiwan which include an identity card number**.

The Business Visa

Business Visa: Recommended for exhibitors and business visitors.

- **Short-Stay Visa (Schengen Visa): Business Visa**

If your stay will not exceed 90 days, you should apply for a **Short-Stay Schengen Visa (Category C) for Business Purposes**. This visa permits participation in business activities such as meetings, conferences, and trade fairs within the Schengen Area.

Definition of Business Purposes:

- Attend business meetings and negotiations.
- Participate in conferences, seminars, and trade shows.
- Visit clients, partners, or suppliers.
- Conduct market research.

However, it does **not** permit you to:

- Engage in paid employment within the Schengen Area.
- Provide services to a company or individual in the Schengen Area.
- Establish a business or open a branch of your company.
- For more detailed information, you can refer to the Federal Office for Migration and Refugees (BAMF) guidelines on entry regulations. [BAMF](#)

Important Considerations:

- **Visa Validity:** The Short-Stay Schengen Visa allows stays of up to 90 days within a 180-day period.
- **Application Process:** You must apply through the German embassy or consulate in your country of residence.
- **Required Documentation:** Typically includes a valid passport, completed application form, recent photographs, travel itinerary, proof of accommodation, travel health insurance, proof of financial means, and an invitation letter from the business partner or event organizer in Germany.

Eligibility & Requirements

It is crucial to access public, reliable sources relevant to your country of residence for specific visa requirements. This ensures you are aware of the most accurate and up-to-date guidelines from your local embassy or consulate. While requirements may vary slightly by country, the following represents the **basic eligibility and documentation** needed for a Schengen Visa

General Requirements:

Completed visa application form: Ensure it is correctly filled out and signed.

Valid passport: Must be valid for at least three months beyond your intended stay and include at least two blank pages.

Recent passport-sized photographs: Must meet Schengen visa photo specifications.

Proof of accommodation: Includes hotel bookings, a confirmation letter, or a host invitation if staying with someone.

Proof of financial means: Recent bank statements, sponsorship letters, or proof of income sufficient to cover your expenses.

Travel insurance: Coverage for medical emergencies, valid for all Schengen Area countries.

Round-trip flight reservation or travel itinerary: A clear document showing your entry and exit plans.



Eligibility & Requirements

Additional Requirements for Exhibitors:

Official Invitation Letter from GITEX EUROPE:

The official invitation letter must clearly state your participation in the event and its purpose.

How to Receive an Official Invitation Letter as an Exhibitor:

- You will receive login details for the Ezone portal via email from GITEX.
- Once logged in, you will need to complete the mandatory registration form with your information.
- After completing the registration, go to the visa section using the search bar, which will direct you to the visa form.
- Fill out the visa letter form.
- You will receive two visa invitation letters: one from our German partner, Berlin Partners, and another from our German office, KAOUN GmbH. These letters will either be sent to your email or made available for download on the Ezone portal.

Important Note:

Please note that the visa letters that we issue are only valid with the participation letter, which you can fill out and download on the Ezone under forms.



Eligibility & Requirements

Additional Requirements for Visitors:

Official Invitation Letter from GITEX EUROPE:

The official invitation letter must clearly state your participation in the event and its purpose.

How to Receive an Official Invitation Letter as an Exhibitor:

- Visit the GITEX EUROPE website and use the search bar to look for the visa section.
- A form will appear asking if you are an exhibitor or a visitor. Select "**visitor**" from the options.
- Complete the form with the required information.
- After submission, you will receive two visa invitation letters: one from our German partner, Berlin Partners, and another from our German office, KAOUN GmbH. These letters will be sent to your email address.

Important Note:

Please be aware that the visa invitation letters we provide are only valid if you also purchase a GITEX ticket. The consulate will require you to present the ticket along with the visa letters when applying for your visa.

GERMANY VISA APPLICATION REQUIREMENTS

One of the most important factors of the application process for a German visa is the **required documents**.

The German embassy or consulate handling your visa application will base their decision on whether to grant your visa based on the documents you submit. Please ensure that your document checklist is in order and that nothing is missing.

GERMANY VISA REQUIREMENTS

Below is a list of the documents required for a **Germany visa application**:

- Germany Visa Application Form.
- Valid Passport.
- Two identical Germany Visa Photos.
- Proof of Accommodation in Germany.
- Transportation / Round trip reservation or itinerary.
- Adequate Health Insurance Coverage.
- Proof of Financial Means.

Please note that these steps may not be required in the same order, this is different based on where you apply for your visa.



GERMANY VISA APPLICATION FORM

You should start your application procedure by **fulfilling the German visa application form**.

[Click here](#) to access the German visa application forms.

- If you are applying for a **German short stay visa**, you need a **Schengen visa application form**.
- Give detailed and accurate information about yourself and the **purpose of your travel** that complies with the information in the other required documents. **Print the form and sign it at the end.**

VALID PASSPORT

[Your passport has to be valid for a minimum of 3 months](#) before the due date in order to be eligible to apply for a visa for Germany. If your passport **has expired**, be prepared to **not be able to travel**. It should also fulfill the other passport requirements, as having one blank page in order to be able to affix visa sticker in it. Keep in mind that your passport will remain at the embassy throughout the time of your application processing.

TWO IDENTICAL GERMANY VISA PHOTOS

Two photos for your Germany visa application are mandatory. They must [fulfil all of the German visa photo requirements](#), including being in the right size, color and face position.

PROOF OF ACCOMMODATION IN GERMANY

A document that shows you have a place where you will be staying **throughout the time you are in Germany**, must be presented to the visa officer. This document could be a **hotel booking, a rental agreement, a letter of invitation by a host, or proof you own a house/apartment in Germany**.

TRANSPORTATION / ROUND TRIP RESERVATION OR ITINERARY

[A booked flight ticket](#), train ticket or a ticket of other means of transport should be submitted as a **proof of the date you will enter and leave Germany and the transport you will use to reach there**.

ADEQUATE HEALTH INSURANCE COVERAGE

A document, which shows you have purchased [travel insurance valid for Germany](#) and the rest of Schengen area, covering medical emergencies throughout the whole time you will be staying in Germany, is mandatory. If you intend to **stay longer** and have applied for a long-stay visa to Germany, you should check the German health insurance options.

PROOF OF FINANCIAL MEANS

According to the European Commission information, a foreign applicant applying for a German Visa must be able to attest **possessing €992/month** to the German Embassy or Consulate for the period of stay in German territory. This could be a bank statement, a letter of sponsorship by another person or a combination of both.

Keep in mind: An incomplete documentation file is one of the most common reasons for Germany visa denial.





GERMANY VISA REQUIRED DOCUMENTS BASED ON EMPLOYMENT STATUS

You need to submit additional documents depending on your employment status, as explained below:

EMPLOYED

If you are **employed**, you will have to submit the following documents:

- Employment contract. The document must state your position and the date you started working there.
- Current bank statement of the latest 6 months.
- Leave permission from the employer. The permission must state that the company permits you to take the annual leave during that period.
- Income Tax Return (ITR) form or Certificate of Income Tax deducted at the source of salary.

SELF-EMPLOYED

If you are self-employed, you will have to submit the following documents:

- A copy of your business license.
- Company bank statement for the latest 6 months.
- Income Tax Return (ITR).

STEP 02

COMPLETE THE GERMAN VISA APPLICATION FORM

Before you begin the visa application process to Germany, you 180-day make sure that you have the correct visa form. There are two main types of German visa application forms:

- A short-term visa form (visa C). This is the application form for a business visa that allows you to enter and visit Germany for as long as it's valid- 90 days in a 180-day period.

For either visa form, you must fill in your personal details and the required information online.

You can do this by using VIDEX, which is an online platform designed to make the application process easier for you and for the visa office.

[Once you complete the online form](#), you will have to print it and sign it so you can take it with you when you go to the embassy or consulate.

Make sure you answer all the required questions and be as honest as you can.

STEP **03** **GET YOUR DOCUMENTS READY**

The online platform deletes your data if you don't work on the application for 10 minutes, so before you start make sure you have your documents ready & near you. Documents required are as follows:

- Passport.
- Travel schedule (flight number)
- German address
- Hotel reservation (if applicable)
- Letter of invitation (if applicable)
- Registration E-Ticket
- You can also download the PDF version of the visa forms and complete it in person.

STEP 04 GET YOUR DOCUMENTS READY FOR YOUR VISA APPOINTMENT AT CONSULATE OR EMBASSY

Get Your Documents Ready For Your Visa Appointment at Consulate or Embassy

After you have your printed application form, you will have to get your documents ready. Generally, you need to have the following documents:

- Visa application form.
- Your passport.
- Your visa pictures.
- Travel itinerary.
- Proof of financial means.
- Evidence of accommodation in Germany.
- Proof of purchased health insurance.

These are only the main requirements, for each visa type you need some specific documents such as work contract, school records, family certificate, and so on. See the full list of documents on [Applying for a Schengen visa - European Commission](#)

Some of your documents may require translation or an apostille stamp, so make sure you contact the nearest visa office in your country before you apply and ask how to prepare your documents.

STEP **05** **MAKE AN APPOINTMENT AT AN EMBASSY/CONSULATE**

Visa applications are processed by consulates, and sometimes embassies when a consulate is non-existent in a specific country. You must find the nearest consulate to you, embassy, or another official visa office that oversees issuing German visas for your country. You can look here for a visa representative authority.

Usually, you can book an appointment online depending on the German mission that is available in your country, but sometimes you may be required to go in person and make your appointment.

STEP **06** **GO TO THE VISA INTERVIEW**

Once your appointment for a German visa is confirmed, you have to attend your interview at the visa office. Make sure you arrive on time as your appointment will be canceled if you arrive even a few minutes later.

During the interview, you will be asked questions about your trip to Germany, why you want to travel, how much time you want to spend there, and do you plan on visiting other places. You may also be asked some questions about yourself- the entire interview should not last more than around 10 minutes.

STEP **07** **PROVIDE YOUR BIOMETRIC INFORMATION**

When you go to the embassy/consulate, you also must submit your biometric data. If you've already done this for previous German visas, you may not be required to do the same again. If it's your first trip, after your interview, an officer will scan your fingerprints.

STEP **08** **PAY THE VISA APPLICATION FEE**

In most cases, you will have to pay the visa fee before your interview. However, this requirement changes from country to country. In some countries, you must pay the visa fee online when you fill in the application form and then you must bring your receipt with you, while in other countries you may be required to pay the fee after your interview is over.

Nevertheless, when you visit the embassy/consulate for your interview your visa fee must be paid. The usual fee for a short-term visa is €90, but the cost is liable to change depending on what type of German visa you are applying for.

STEP **09** **GETTING YOUR GERMAN VISA**

Once your application has been completed, you must wait for 10 to 15 business days to get an answer on your visa application. If your application was successful, you can now travel to Germany with your visa and attend GITEX Europe 2025.

In case your visa is rejected, in the rejection letter you will get detailed information about why your visa was rejected and how you can appeal the decision- usually, you have one month to appeal at the local mission where you initially applied for the visa.

SPECIAL CONSIDERATIONS

- **High-Demand Periods:**
Embassies experience high volumes of applications before major events like GITEX Europe. Apply at least **6-8 weeks in advance**.
- **Peak Travel Seasons:**
Consider school holidays and public holidays in your country and Germany when planning your visa application.
- **Handling Rejections or Delays:**
In case of a visa rejection, request a detailed explanation and consider reapplying with additional supporting documents.
- **Country-Specific Requirements:**
Some countries may require additional documents such as a no-objection certificate or previous travel history. Check specific guidelines for your country.
- **Follow Application Instructions Precisely**
Adhere to the guidelines provided by the German embassy or consulate, including form completion, submission procedures, and appointment requirements.
- **Provide Supporting Evidence Where Necessary**
Strengthen your application with additional documents, such as proof of ties to your country of residence , to demonstrate your intent to return after the event.
- **Agency Support**
Consider using a concierge service if you have never applied for a business visa and need guidance. (Refer to OneVasco Details)

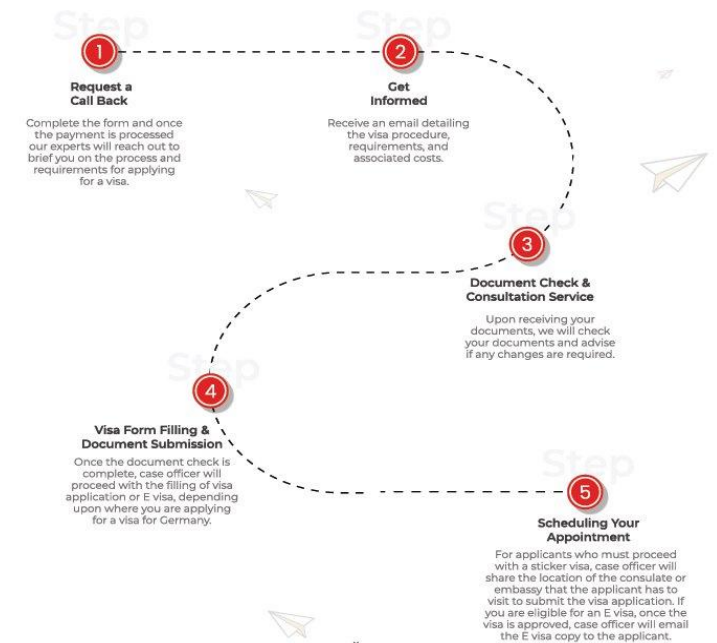
